10-A Request from the Police Chief to promote Ethan Fitzjurls of Belfast as a Patrol Sergeant for the City of Belfast.

The City of Belfast advertised the position of Patrol Sergeant for the Belfast Police Department beginning on December 17, 2025. Applications were accepted until January 14, 2026. The City received applications from several well-qualified candidates.

On January 28, 2026, the Patrol Sergeant Hiring Committee held interviews. The Hiring Committee was composed of Police Chief Robert Cormier, Deputy Police Chief Jennifer Hatch, HR Administrator Nancy Driscoll and me.

Following the interview, the hiring committee unanimously selected Ethan Fitzjurls of Belfast as a Patrol Sergeant for the City of Belfast Police Department.

Officer Fitzjurls is a graduate of Belfast Area High School and the University of Southern Maine. He worked for GAC Chemical in Searsport for eight years until November 2022 when he was hired as a full-time Police Officer for the City of Belfast. Since his hire, Officer Fitzjurls has demonstrated a strong work ethic, leadership skills, and a commitment to excellence, particularly including speed enforcement and data collection.

This position is a vital aspect of the City's public safety team and is responsible for the supervision of police patrols while providing ethical leadership and creating a cohesive work environment that garners the confidence and respect of the Belfast Police Department staff as well as members of the community. Both Chief Cormier and I are confident that Officer Fitzjurls, if confirmed, will continue to serve our community and the Department well.

If approved by the City Council, City staff requests that a motion is made to confirm Ethan Fitzjurls as a Patrol Sergeant for the City of Belfast. If appointed, Officer Fitzjurls will be sworn in by the City Clerk.

Please see the attached cover letter, resume, advertisement, and job description (10-A) providing further detail. Chief Cormier and Officer Ethan Fitzjurls will be present at the meeting.

10-B Request from the Fire Chief to approve 2-year Ambulance and Fire Contract Rates.

In 2025, City of Belfast Fire and Ambulance Service responded to 3,022 calls for service. 2,558 of those calls were Emergency Medical Service (EMS) calls requiring an ambulance and 464 calls that were fire related.

The City of Belfast provides a contracted ambulance service to Belfast as well as the five towns that surround us (Northport, Belmont, Morrill, Waldo and Swanville) and fire suppression service by contract to the Town of Swanville.

Over the last 10 years, we have experienced a 38% increase in emergency ambulance calls. The increase in emergency calls and demand for timely EMS responses has led to increased staffing levels, overtime charges, equipment, and supply fees.

At the direction of the City Council, we have been carefully reviewing the costs to provide all City of Belfast services and the user or contract fees associated with them to verify that they are equitable for Belfast taxpayers.

As part of this process, the Belfast Ambulance Service was analyzed regarding the cost of services. When the cost of providing the service is compared with the current rates being charged for contracts, it becomes clear that the City has been providing a significant subsidy to our contract partners, and it is necessary to work toward a fairer allocation of costs so that the cost per call for Belfast taxpayers is not higher than it is for taxpayers in contracted towns.

The total of all operational costs for the Belfast Ambulance Service in 2025 was \$1,282,778.44. This base rate calculation includes wages for full and part time employees, shift differentials, holiday time, overtime, employee benefits, ambulance supplies, vehicle maintenance, training, uniforms, ambulance billings services in addition to gas, oil, grease and diesel.

The total number of EMS calls in 2025 was 2,558. To determine the cost per call, the base rate of \$1,282,778.44 was divided by 2,558 calls, totaling \$501.48 per call. This cost was applied to the number of calls each community had in the prior calendar year:

Currently, with the five contracted towns, revenues from those contracts total \$75,446. With the base rate of \$501.48 per call and multiplied by 2025 call data for the specific town, this will generate an increase in revenue for Year 1 by \$64,968.40 for total contract fees of \$140,414.40. Year 2 will total \$280,828.80 in contract fees. Breaking the increase to the contracted towns over two years is further recommended to allow for adjustment and planning.

In consideration of the fact that the City of Belfast bills patients for ambulance calls, there is no additional charge added to account for the equipment cost for capital equipment purchase and replacement or for building costs related to housing the capital equipment and personnel. The base rate is based on operational costs only.

The current fire contract rate for the Town of Swanville is \$40,003.00. The current hourly equipment rate is \$150.00 and \$22.05 per hour for labor. The Fire Chief recommends increasing the labor rate from \$22.05 to \$27.35 to align with current wages and maintain the current contract and equipment rates.

Belfast responded to 41 fire emergency calls in Swanville in 2025. The Town of Swanville paid an additional \$14,580.25 in equipment and labor charges last year.

If approved by the City Council, Chief Richards recommends a motion be made to approve 2-year Ambulance and Fire Contract Rates as presented.

Please see the attached memo and supporting documents (10-B) from Fire Chief Patrick Richards providing further details. Chief Richards will be at the meeting to answer any questions.

10-C Request from the Fire Chief to enter into a 2026 Waldo County Fire Protection Mutual Aid Agreement.

Mutual aid is an agreement between fire departments to assist each other when an emergency exceeds the capabilities of a single department. Waldo County has a long history of successful mutual aid between departments that have benefited the towns and the people they serve.

In 2025, the Belfast Fire Department provided mutual aid 21 times to the following communities:

- Searsport: 4
- Morrill: 1
- Northport: 7
- Belmont: 3
- Waldo: 5
- Verona Island: 1

In 2025, Belfast received mutual aid 4 times from the following communities:

- Morrill
- Belmont
- Searsport
- Northport
- Monroe

Mutual aid agreements are typically reevaluated every five years. The City Council approved the last agreement on March 2, 2021. Waldo County Emergency Management Agency recently reviewed and updated Waldo County Fire Protection Mutual Aid Agreement for the next five years. The Fire Chief has reviewed the 2026 agreement and recommends its approval. Once signed, the agreement will remain in effect for the next five years.

If approved by the City Council, a recommended motion would be to approve the 2026 Waldo County Fire Protection Mutual Aid Agreement.

Please see attached draft agreement (10-C). Fire Chief Patrick Richards will be at the meeting to present and answer any questions.

10-D Request to approve the Certificate of Commitment of Sewer User Rates for the period of July 1, 2025, through December 31, 2025.

The Certificate of Commitment of Sewer User Rate certifies and commits a true list of the sewer rates established by us pursuant to 30-A M.R.S.A. Section 3406 for those properties, units and structures required by local and state law to pay a sewer rate to the municipality. This list is comprised of the pages numbered 1 to 51 inclusive which are attached to the certificate. The date on which the rates included in this list are due and payable is March 19, 2026.

The City of Belfast is hereby required to collect from each person named on the attached list his or her respective amount as indicated in the list, the sum total of those listings being \$681,339.23. The City of Belfast will hereby be required to charge interest at the rate of 7% per annum on any unpaid account balance beginning March 20, 2026.

If approved by the City Council, a recommended motion would be to approve the Certificate of Commitment of Sewer User Rate for the period of July 1, 2025, through December 31, 2025.

10-E Signing of Council Orders

Presidents' Day is on Monday, February 16th, 2026, this year. This is a federal holiday, originally established in 1885 in recognition of President George Washington.

This holiday became known as Presidents' Day after the date was changed to the third Monday of February each year, as part of the Uniform Monday Holiday Act signed in 1968 by President Lyndon B. Johnson. Since then, Presidents' Day has been viewed as a day to celebrate all who have served as President of the United States. Public schools often spend the days leading up to Presidents' Day teaching students about the accomplishments of these leaders.

Presidents' Day has served as a time of patriotic celebration and remembrance. This holiday gained special meaning during the difficulties of the Great Depression, when portraits of George Washington often graced the front pages of newspapers and magazines every February 22nd. In 1932, the date was used to reinstate the Purple Heart, and in 1938, approximately 5,000 people attended mass at Saint Patrick's Cathedral in New York City in honor of President Washington.

To this day, Presidents' Day offers an opportunity to reflect on leadership itself, including its responsibilities and challenges, as well as the leaders who have shaped our nation and how our sense of history keeps evolving.

The successful candidate will serve under the direct supervision of the Deputy and Chief of Police and work effectively as a team with our officers and City Departments. BELFAST POLICE DEPARTMENT

NATURE OF WORK:

The Patrol Sergeant serves under the direct supervision of the Deputy Chief of Police.

The Patrol Sergeant serves as Shift Commander for the supervision of the police patrol and related police and station activities; supervises, directs and evaluates patrol officers, provides information and training, and performs other administrative duties as needed; works as a Patrol Officer as needed.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

1. Performs all responsibilities outlined in the Patrol Officer's job description.
2. Acts as Shift Commander for a patrol shift, including the following:
 - a. Checks the assignment instruction;
 - b. Instructs personnel in methods and procedures and offers aid in those areas;
 - c. Assists officers in handling emergency situations and reviews handling incidents;
 - d. Assumes command at emergency situations; and
 - e. Participates in patrol and traffic enforcement duties.
3. Supervises daily operations and distribution of police patrol forces during the shift.
4. Serves as a liaison to other City Departments and outside agencies; calls on Public Services and handles mutual aid requests as needed.
5. Supervises the preparation of police records during the shift; reviews for accuracy and correctness and returns those needing corrections.
6. Reviews and recommends changes to police department policies and procedures.
7. Ensures that patrol vehicles are clean and in good working order; troubleshoots issues and assists with minor repairs, or makes arrangements for repairs, as needed.
8. Performs the duties of a supervisor including scheduling, training, supervising, evaluating, recognizing and disciplining direct reports, setting employee goals and objectives, resolving employee issues, and ensuring compliance with the Union Contract, Employee Handbook and related personnel policies.

NON-ESSENTIAL DUTIES AND RESPONSIBILITIES:

1. May assist with grant writing, tracking and administration.
2. May assist with departmental technologies, such as MCRS, Spillman, Website maintenance, etc.
3. In the absence of a Supervisory Officer above this rank, due to vacation or illness, a Patrol Sergeant will have to conduct himself under the job description of that rank when requested by the Chief of Police or City Manager.
4. Performs additional duties as assigned by the Deputy Chief of Police or Chief of Police.

GENERAL EXPECTATIONS:

1. Be committed to the mission of the City of Belfast.
2. Be reliable and trustworthy.
3. Be well organized.
4. Be punctual for scheduled work and use time efficiently.
5. Be able to work harmoniously with co-workers and with the public.
6. Perform duties in a safe, conscientious and cooperative manner.

7. Be neat and maintain a professional appearance.
8. Understand and work within the Department's and City's Policies and Procedures.
9. Maintain confidence by keeping information concerning employees, personnel issues and City operations confidential.

PHYSICAL REQUIREMENTS:

The physical requirements described here are representative of those that must be met by the Incumbent to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee is regularly required to sit, stand, walk, talk, hear, read, write, and use hands and fingers to operate a standard keyboard, use a computer, printer, copier, fax, telephone, radios, handgun, handcuffs, shackles and other restraint devices, chemical agents, collapsible baton, firearm, and bullet resistant vest. The employee may be required to climb, crouch, crawl, bend or stoop, push, pull or drag objects. The employee must occasionally lift and/or move up to 50 pounds and must be able to control an unruly individual. Specific vision abilities required by the job include close vision, color and distance vision, depth perception and the ability to adjust focus. Equipment used includes all normal office equipment, high performance motor vehicles, boats, firearms and other police related weapons, communication equipment including 2-way radios and cell phones, specifically designed clothing/apparel, and other equipment as needed in special circumstances.

WORK ENVIRONMENT:

The work environment characteristics described here are representative of those the incumbent encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

The work environment varies from an office setting, to all types of outdoor environments including adverse and hazardous weather conditions, to operating a police cruiser, boat or other equipment, to varied citizen home conditions. Constant exposure to mental and/or physical stress due to the level of responsibility in protecting the public, dealing with irate people, and dealing directly with the public. The nature of the work involves exposure to unpredictable situations which may hazard life or limb, including potential exposure to Bloodborne pathogens, biohazardous materials and waste, second-hand smoke, narcotics and individuals with contagious diseases.

QUALIFICATIONS NEEDED FOR POSITION:

Experience and Skill Requirements: The following experience and skills are considered essential:


- Have a minimum of 3-5 years of progressively responsible law enforcement experience, or an equivalent combination of education and experience demonstrating the required knowledge, skills, and abilities. Five years of experience is preferred.
- Seasoned judgment and skill in leading personnel and in interpreting departmental policies and regulations.
- Ability to understand and carry out oral and written instructions and to prepare clear and comprehensive written orders.
- Ability to assign, instruct and review the work of police subordinates.
- Ability to deal with the public courteously and firmly and to establish and maintain effective working relationships.
- Ability to analyze situations and to adopt quick, effective and reasonable course of action.

Education Requirements: The following education requirements are considered essential:

- High School diploma or equivalent required; Associate's Degree or higher in Criminal Justice studies preferred.
- Must be a graduate of the Maine Criminal Justice Academy or have been waived or be eligible for such a waiver by the Academy Board of Trustees.
- Annual Firearms Qualification and other MCJA required annual training.
- Knowledge of modern police methods and procedures.
- Knowledge of the rules and regulations of the police department.
- Knowledge of first aid and knowledge of application of same.
- Knowledge of pertinent federal and state laws and of City ordinances. Considerable knowledge of the geography of the community and of the location of important buildings and areas requiring various police services.

Re; 5 Town Ambulance Contracts

I present a 2-year contract proposal for our neighboring 5 town Ambulance response. The towns included here are Northport, Belmont, Morrill, Waldo, and Swanville. In the past our contract rates have been extremely low with a gradual increase over the last several years. With contract rates so low, it has been difficult to maintain actual operating costs or distribute them evenly to our subscribers resulting in the City of Belfast subsidizing its ambulance service to the outside communities. Over the last 10 years, we have experienced a 38% increase in emergency ambulance calls. The increase in emergency calls and demand for timely EMS responses has led to increased staffing levels, overtime charges, equipment, and supply fees.

We are now at a time where we must analyze the cost and distribute this evenly to those that receive the service. The Finance Director and I have broken down the expenses and determined what the operational cost is per resident as well as for every call responded to. The population for each town is difficult to determine accurately as there is such a fluctuation with seasonal residents and tourists. Therefore, we have determined a base rate per call that will be distributed based on the most recent call volume for 2025. Each town has gradually increased as well but remained consistently close in the last 2 years to their 2025 call volumes.

I recommend breaking the increase to the contracted towns over two years to allow for adjustment and planning.

A base rate of 501.48 per call has been calculated by dividing the overall operational cost of the Ambulance Department by the amount of overall ambulance responses.

$\$1,282,778.44 / 2,558 \text{ (calls)} = \501.48 per call

Currently, with the 5 contracted towns, revenues from those contracts equal \$75,446. With the base rate of 501.48 per call and multiplied by 2025 call data for the specific town, this will generate an increase in revenue for year 1 by \$64,968.40 for a total contract revenue of \$140,414.40. Year 2 will be \$280,828.80 in total.

I have attached the worksheet used to calculate operational expenses as well as the projected contract rates for each town.

The Fire contract for the Town of Swanville has been more realistic compared to EMS. I recommend the current Fire contract for the Town of Swanville, \$40,003.00 and the current hourly equipment rate, \$150.00, and an adjustment to the labor rates. Swanville currently pays \$22.05 per hour for labor. I recommend increasing this charge from \$22.05 to \$27.35. The Town of Swanville paid an additional \$14,580.25 in equipment and labor charges last year. We responded to 41 Fire emergency calls.

WALDO COUNTY FIRE PROTECTION MUTUAL AID AGREEMENT

A. PURPOSE:

The undersigned Municipal Officers for municipalities in the County of Waldo, State of Maine; hereby agree to render emergency mutual aid services during emergency and disaster events requiring the activation and deployment of their fire department, in accordance with Title 30-A M.R.S.A. Chapter 115 and Title 30-A M.R.S.A. § 3156.

B. DEFINITIONS:

1. A Requesting Department is the municipal/volunteer fire department requesting support from other municipal/volunteer fire departments.

2. A Supporting Department is the municipal/volunteer fire department that is providing support to the requesting municipal/volunteer fire department.

3. A Member Municipality is a municipality whose municipal officers have signed and approved this mutual aid Agreement.

3. A Senior Fire Officer (SFO) is the senior ranking fire department officer (Chief, Deputy, Assistant, Captain, Lieutenant) present for duty, at that time, during an emergency activation of the fire department.

4. The Incident Commander (IC) is the individual responsible for all incident activities, including the development of strategies and tactics and the ordering and release of resources. The IC has overall authority and responsibility for conducting incident operations and for the management of all incident operations at the incident site. All responding departments will be under the command of the IC while located on scene at the incident.

5. The RCC is the reference to the Waldo County Regional Communications Center.

6. EMA is the reference to the Waldo County Emergency Management Agency.

C. ROLES AND RESPONSIBILITIES

1. Each member municipality agrees to establish a fire department personnel accountability system that is compatible with one another. They further agree to share fire department equipment resource lists.

2. The Requesting Department shall be responsible for establishing an Incident Command System (ICS) in accordance with NIMS and NFPA 1561. The SFO from the Supporting Department shall report to the IC for all assignments. Individual department integrity should be maintained to the greatest extent possible.

3. The Incident Commander shall be responsible for implementing an incident safety program and a personnel accountability program at the disaster or fire scene.

4. The Incident Commander should complete a size-up report and call the following applicable information to the RCC, so that all responding agencies/personnel will know what is happening:

- a. Apparent Conditions (Nothing showing, Fire Showing, Working fire, or fully involved, etc.)
- b. Structure Type (Occupancy, Size, Height, etc.)
- c. Attack Strategy (Offensive or Defensive)
- d. Staging Location

D. PROCEDURES FOR REQUESTING AND PROVIDING ASSISTANCE

1. Upon a request to the Waldo County Regional Communications Center (RCC) by the Senior Fire Officer (SFO) of a municipality possessing an emergency or disaster, the RCC shall dispatch those Supporting Departments as requested by the requesting SFO. The requesting SFO shall request the type of equipment needed, such as pumpers, tankers, aerials, ladders, manpower, etc. This request should be available and announced on the initial page for the Supporting Departments.
2. The SFO of each Supporting Department shall acknowledge the request by the SFO of the Requesting Department by signing on and stating that their department acknowledges the page and gives the status of the Supporting Department's response.
3. Unless the Incident Commander (IC) has asked that the Supporting Department be directed to take up a position remote to the incident, the Supporting Department shall respond directly to the staging area at the incident scene. Upon arrival at the scene, the SFO of the Supporting Department shall report to the IC to report availability and receive direction.
4. The rendering of assistance under the terms of this Agreement shall not be mandatory, but the Supporting Department should immediately inform the Requesting Department if, for any reason, assistance cannot be rendered. Mutual aid shall not be requested by a member municipality unless resources available within the Requesting Department are deemed to be inadequate.
5. In the event that a Supporting Department is concerned about coverage of their own municipality during the incident, the Supporting Department may request, through the RCC, that another member municipality be placed on standby to address those coverage concerns.
6. A Supporting Department shall be released by the Requesting Department when the services of the supporting department are no longer required or when the Supporting Department is needed within the area for which it normally provides emergency and disaster response. The Supporting Department shall make it known to the Incident Commander that they need to leave before departing the scene.

E. INTEROPERABLE COMMUNICATIONS

1. The member municipalities agree to establish common radio protocols.
2. Each municipality that has signed on to this mutual aid Agreement hereby authorizes the other member municipalities to program their fire department radio frequency into their base, mobile and portable radios. Departments that do not "own" the radio frequency should only utilize that frequency during an emergency or disaster involving the "owning" department.
3. The Incident Commander shall have the responsibility for coordinating communications between the personnel of the Supporting Departments and the Requesting Department.

F. RELATIONSHIPS WITH OTHER AGREEMENTS

1. This Agreement does not replace any "Automatic" agreements that individual municipalities have signed with one another. Automatic Agreements allows for two or more fire departments to be dispatched automatically and simultaneously in order to respond to a single incident in a member municipality.
2. This Mutual Aid Agreement is a "Call" agreement, whereby a requesting department must ask for a supporting department to be dispatched by the RCC in order for the supporting department to respond.

G. COMPENSATION, REIMBURSEMENTS, LIABILITY AND WORKERS COMPENSATION

1. Each member municipality to this agreement shall be responsible for compensation of damages to its own equipment and vehicles which occurs while aid to the other municipality is being rendered.
2. Each member municipality to this agreement shall be liable for its own actions which occur while aid to the other municipality is being rendered.
3. Each member municipality shall be responsible for compensation for injury or death of its own firefighters which occurs while aid to the other municipality is being rendered.
4. The SFO from each Supporting Department shall be responsible for ensuring that their firefighters are qualified and capable of completing the assignments given to them. An example would be firefighters who are not qualified to perform interior firefighting will not be assigned to perform interior firefighting.
5. Should the Requesting Department seek reimbursement for services performed from hazardous materials spillers, insurance, courts or the like, the Requesting Department will also include reimbursement for all Supporting Departments that were included in the response.
6. All Departments shall compensate (or not compensate) their own members according to their own department policies. Supporting Departments will not seek wage/stipend compensation from Requesting Departments, unless agreed to in writing between both departments.

H. AGREEMENT REPRESENTATIVE

1. The duly appointed municipal or volunteer fire chief from each member municipality shall represent the municipality on any discussions concerning the Mutual Aid Agreement.
2. No provision of this Agreement may be modified, altered, or rescinded without the approval of the Municipal Officers of all member municipalities.

I. DURATION

1. This Agreement shall remain in effect for a period of five (5) years from the date of final signing, at which time said Agreement may be renewed.

J. WITHDRAWING FROM THE AGREEMENT

1. Any member municipality that desires to withdraw from the Waldo County Fire Protection Mutual Aid Agreement shall provide a written and signed resolution letter to the Director of the Waldo County EMA at least 30 days prior to withdrawing from this Agreement.

K. COPIES PROVIDED

1. This Agreement shall be filed on record with the municipal clerk from each member municipality. It shall also be kept on file at each fire department of each member municipality. A copy of this Agreement shall also be provided to the RCC and EMA.

L. VALIDATION

1. Should any portion or section of this Agreement be held to be invalid by a court of competent jurisdiction, that fact shall not affect or invalidate any other portion or section; and the remaining portions of this Agreement shall remain in full force and effect without regard to the section or portion or power invalidated.
