

**CITY COUNCIL ACTION OF OCTOBER 16, 2018
SECOND READING OF
PROPOSED AMENDMENTS TO CITY CODE OF ORDINANCES
ROUTE ONE SOUTH BUSINESS PARK ZONING DISTRICT**

FIRST READING, SEPTEMBER 25, 2018:

The Belfast City Council, at its meeting of September 25, 2018, conducted the formal First Reading and an accompanying public hearing regarding proposed amendments to City Code of Ordinances associated with the establishment of the Route One South Business Park Zoning District. Amendments are associated with the proposal by Nordic Aquafarms to establish a land based salmon aquaculture farm in the area affected by the Ordinance amendments and include changes to Chapter 66, General Provisions, Chapter 82, Shoreland, Chapter 102, Zoning. The Council, at its meeting of September 25, supported the First Reading language identified in the proposed amendments being presented for formal Second Reading and public hearing, with one change to the proposed Ordinance language in Chapter 102, Zoning, Article VIII, Supplementary District Regulations, Division 7, Significant Groundwater Wells. Council vote was 5-0.

SECOND READING, OCTOBER 9, 2018:

The Belfast City Council, at its meeting of October 9, 2018, conducted the formal Second Reading and an accompanying public hearing regarding proposed amendments to City Code of Ordinances associated with the establishment of the Route One South Business Park Zoning District. Amendments are associated with the proposal by Nordic Aquafarms to establish a land based salmon aquaculture farm in the area affected by the Ordinance amendments and include changes to Chapter 66, General Provisions, Chapter 82, Shoreland, Chapter 102, Zoning. The Council, at its meeting of October 9, acknowledged that it conducted the Second Reading and scheduled Council deliberations on the amendments for its meeting of October 16, 2018. Council vote was 4-0 (Councilor Mortier was absent).

COUNCIL ACTION ON SECOND READING OF AMENDMENTS, OCTOBER 16, 2018.

The Belfast City Council, at its meeting of October 16, 2018, discussed and considered the action it would take on the Second Reading of the Ordinance amendments for the Route One South Business Park district. The Council, after extensive discussion, adopted the following motions:

Motion to adopt amendments to Chapter 102, Zoning, associated with establishment of the Route One South Business Park District, as such were read at the Second Reading. Vote 5 - 0.

Motion to adopt amendments to Chapter 82, Shoreland, associated with establishment of the Route One South Business Park District, as such were read at the Second Reading. Vote 5 - 0.

Motion to adopt amendments to Chapter 66, General Provisions, associated with the establishment of the Route One South Business Park District, as such were read at the Second Reading. Vote 5 - 0.
